DPHP will implement an approved version of a Public Access Signage Plan promoting access to California Coastal Trails, Public Access, Environment Awareness, Safety and Informational that includes:

- A. Informational and directional signage will include but not limited to:
 - a. Coastal Trails (Incorporating CCT Logo), Parking Areas, Public Promenade, No Smoking, No littering, Public Dock Access, Trash/recycling receptacles, EV Charging Stations, Boat Pump Out Stations
 - b. (See attached examples)
- B. All signage will provide clear information and in key locations for all visitors and tenants, to include but not limited to:
 - High traffic areas, Crosswalks, Promenades, Walkways, Entrance and within Parking Lots, Restrooms, Gate entrance to docks, On docks and Boater Service Buildings
 - b. Signage and harbor maps will be at a minimum in English and Spanish
- C. Signage will be designed and manufactured in a quality manner without adversely affecting public views and/or site character. Any existing signs that do not meet such criteria will be removed.




