**NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN THAT a public hearing will be held by the City Council of the City of Dana Point to consider the following:

**Amendment to Coastal Development Permit CDP13-0018:** Pursuant to Coastal Act Section 30625, appeals have been filed with the California Coastal Commission on the basis that the City's June 17, 2014 approval of the Dana Point Harbor Revitalization Commercial Core Project does not adequately address several policies of the Dana Point Harbor Revitalization Plan and District Regulations. The revisions to the project are intended to supplement the existing documentation and to allow the California Coastal Commission to determine that no substantial issue exists, thereby allowing the City's discretionary approval of the Coastal Development Permit to become final. The Commercial Core project includes renovations of existing buildings, phased demolition of existing buildings along with phased construction of new commercial buildings, reconfiguration/construction of streets and other infrastructure improvements, a new two level parking deck, landscape improvements, a parking management plan and master sign program for the Harbor. Approval in concept is also being requested for a Dry Stack Boat Storage Building.

Any action or proceeding to attack, review, set aside, or void any decision of the Dana Point City Council is controlled by Section 2.50.010 and Section 2.50.020 of the Dana Point Municipal Code. In any such action or proceeding seeking judicial review of, which attacks or seeks to set aside, or void any decision of the Dana Point City Council, shall be limited to those issues raised at the hearing as provided in Chapter 2.50 of the Dana Point Municipal Code.
